2.5 Statistics and Probability

This domain introduces **random sampling** and the comparison of two populations. Technical analysis involves calculating the mean, median, and interquartile range (IQR) to make comparative inferences about data sets.

Step 1: Data Identification and Variable Assignment

Students often apply a scale factor linearly to area or volume. **Technical Correction:** If the scale factor of a shape is r , the area changes by a factor of r^2 and the volume changes by a factor of r^3 . Failure to square or cube the scale factor results in significant calculation errors.

6.2 Integer Operational Errors

Subtraction of negative numbers remains a primary source of error. Benchmarks test this via **Standard 7.3(A)**, requiring students to add and subtract rational numbers fluently. Strategic use of a number line or the "Keep-Change-Change" rule is vital for operational accuracy.

6.3 Calculator Over-Reliance

While scientific calculators are often permitted, they can lead to "syntax errors" if students do not properly use parentheses when entering negative bases with exponents. For example, -3^2 vs. $(-3)^2$ yields different results (-9 vs. 9).

To maximize the utility of 7th-grade math benchmarks, districts should adopt a **Data-Driven Instructional (DDI)** cycle. This cycle transforms raw test scores into instructional action.
