6. Social Domain

The social domain measures interpersonal relationships. It tracks how a child interacts with adults and peers, their ability to follow rules, and the development of self-regulation and emotional expression.

7. Literacy (New to AEPS-3)

Recognizing the importance of early academic readiness, the AEPS-3 introduces a dedicated Literacy domain. This includes phonological awareness, print concepts, and early reading skills essential for the transition to kindergarten.

8. Math (New to AEPS-3)

The Math domain focuses on early numeracy, including counting, number recognition, operations, and spatial relationships. By including math and literacy, the AEPS-3 becomes a comprehensive "school readiness" tool.

The AEPS-3 Scoring Logic and Methodology
