The Kronstadt Rebellion serves as a critical case study in Pipes' narrative. The sailors at the Kronstadt naval base had been the 'pride and joy' of the revolution. However, by 1921, they rebelled against Bolshevik tyranny, demanding 'Soviets without Communists.'
