2. The Z-score

The Z-score compares the patient's BMD to an **age-, sex-, and ethnicity-matched** reference population. This is used primarily in children, adolescents, premenopausal women, and younger men. A Z-score of -2.0 or lower is defined as "below the expected range for age."

Clinical Protocols: Step-by-Step Scanning Procedures

The Forearm (33% Radius)

The forearm is used when the spine or hip cannot be scanned (e.g., due to hardware, extreme obesity, or hyperparathyroidism). The 33% (one-third) radius is the site of interest because it consists primarily of cortical bone.

Quality Assurance and Precision Studies
