NICET Level I and II Core Competencies

The initial levels focus heavily on **NFPA 72** and **NFPA 70 (National Electrical Code)**. Technicians must demonstrate proficiency in: Proper mounting heights for manual pull stations (42 to 48 inches to the actuator). Spacing requirements for heat detectors based on ceiling height and listed spacing. Visual notification requirements (candela ratings) based on room dimensions to ensure ADA compliance.

Hydraulic Principles and Sprinkler Oversight
