For steel inspection, transducers are typically designed to produce refracted angles of 45°, 60°, or 70°. These angles are strategically selected to ensure the beam intersects the weld preparation faces at near-normal incidence, maximizing the reflection from potential planar flaws like **lack of fusion** or **cracks**.

The Near Field and Beam Spread

The region immediately in front of the transducer, known as the **Near Field (Fresnel Zone)**, is characterized by intense pressure fluctuations due to interference patterns. Accurate flaw evaluation is difficult within this zone. The length of the near field (N) is calculated by:

$$N = D^2 f / 4v$$

Where D is the diameter of the transducer element, f is the frequency, and v is the velocity in the material. Beyond the near field lies the **Far Field (Fraunhofer Zone)**, where the beam begins to diverge. Understanding the **Beam Spread Angle** is vital for calculating the effective area covered during a scan and for correcting signal amplitude as the distance from the probe increases.

Technical Specifications for Weld Inspection

According to standard industrial guides (such as SSC-213), the ultrasonic inspection of steel butt welds requires a

disciplined approach to equipment selection and calibration.

Transducer Selection and Frequency

For steel thicknesses between 1/4 and 2 inches, a frequency range of **2.0 MHz to 5.0 MHz** is generally standard. Lower frequencies offer better penetration in coarse-grained materials, while higher frequencies provide superior resolution for detecting smaller, tightly closed flaws. For the majority of structural steel applications, a **2.25 MHz** transducer provides an optimal balance between sensitivity and attenuation loss.

Calibration and Sensitivity Setting

Before any testing begins, the ultrasonic system must be calibrated for both distance (time-of-flight) and sensitivity (amplitude). Calibration blocks, such as the **IIW (International Institute of Welding)** or **ROMAS** blocks, are used to:

- Establish the probe index point (the exact exit point of the beam).
- Verify the refracted angle of the probe.
- Set the time base to correspond with the thickness of the material.
- Determine the Reference Level using a side-drilled hole (SDH) or a notch, which serves as the baseline for evaluating flaw significance.

Step-by-Step Procedure for Ultrasonic Flaw Detection

The inspection process follows a rigorous sequence to ensure 100% coverage of the **Heat Affected Zone (HAZ)** and the weld metal itself.

1. Surface Preparation

The scanning surface must be free of weld spatter, rust, scale, and irregularities. A smooth surface ensures consistent acoustic coupling. A **couplant** (such as oil, grease, or specialized cellulose gels) is applied to eliminate the air gap between the transducer and the workpiece, as ultrasonic energy at high frequencies does not travel through air efficiently.

2. Scanning Patterns

The operator moves the transducer in specific patterns to ensure the beam reaches all parts of the weld volume:

- Pattern A (Lateral Motion): Moving the probe back and forth toward and away from the weld to cover the full cross-section.

Cracks	Sharp, high-amplitude, multi-faceted peaks.	Critical; usually requires immediate repair.
Slag Inclusions	Broad, jagged signals with lower amplitude than cracks.	Significant if elongated or clustered.
Porosity	Clusters of small, rapid-fire echoes.	Often volumetric; evaluated based on density.
Lack of Fusion	High amplitude, specular reflection from a specific depth.	Serious; indicates poor bonding at the weld face.

Acceptance Criteria and Evaluation Limits

Evaluation is not merely about finding a flaw; it is about determining its significance based on established codes such as **AWS D1.1 (Structural Welding Code — Steel)** or **ASME Section V**.

The 8% Rule and Aggregate Length

Where:**A:** The gain in decibels required to bring the flaw signal to the reference level.**B:** The gain used for the reference level calibration.**C:** The attenuation factor (calculated based on the sound path distance).

Lower numerical ratings indicate higher-amplitude reflections, which typically correlate with more severe defects.

Advanced Applications: Rails and Bridges

Railway Inspection

Rail testing focuses on identifying internal fatigue cracks, such as **transverse fissures** and **tache ovals**. Amplitude Correction (DAC) curves is essential here to compensate for the loss of signal strength over the long sound paths common in large bridge girders.

A skilled technician uses the **Depth Equation** to verify the spatial position of the reflector before declaring it a flaw.

Surface Roughness and Attenuation

A rough surface causes scattering of the ultrasonic beam, leading to a loss of sensitivity. If the surface cannot be ground smooth, the operator must increase the **Transfer Correction**—adding extra gain (dB) to compensate for the acoustic energy lost at the interface.
