

The Architecture of the Campus Novel: A Technical Analysis of David Lodge's Campus Trilogy

If *Changing Places* was about two static points, *Small World: An Academic Romance* (1984) is about the **vectors** between points. The 'Quest' is no longer for the Holy Grail, but for the 'UNESCO Chair'—a position of ultimate global prestige and financial reward.
